Job Access Reverse Commute and New Freedom Transportation Funding

Southwest Michigan Planning Commission (SWMPC) and the Twin Cities Area Transportation Authority (TCATA) are partnering for the third year to submit an application for the Federal Transit Administration grants New Freedom (5317) which funds the Mobility Manager position and a number of mobility management projects as well as Job Access and Reverse Commute (JARC)(5316) which funds the continuation of the Red Route and the Blue Route's extended hours. The application will be submitted March 1, 2012. In the past this funding has brought an additional \$580,000 to fund these services.

2) Consolidation of Buchanan Dial-A-Ride

The City of Buchanan has already moved in the direction of consolidation in an attempt to decrease the overall operational costs of their three bus dial-a-ride system. Effective January 1, 2012 the City contracted with Berrien County to operate their bus system. The County in turn subcontracted with their third party operator, Transportation Management, Inc. (TMI), to operate and maintain the Buchanan buses. TMI has operated the Buchanan system since its inception. 3) Niles Transportation Development Plan (TDP)

On February 6, 2012 the steering committee for the Niles Dial- A- Ride Transportation (DART) Development Plan and Laura Brown of RLS, discussed the draft implementation plan which consist of short and long-range goals that will be implemented over a span of 5 years. The alternatives presented in the plan should significantly increase efficiencies in Niles DART services.

Some Of the Highlights Were:

- 1) Increase Efficiencies in Operations
 - Niles DART will transition from immediate request (for dial-a-ride services) to a 24hour advance request system
 - Niles Dial A Ride is currently in the process of implementing a dispatching software program-allowing trips to be scheduled in advance

- Expand hours of operation for demand response services
 - > Niles Dial A Ride would like to provide two more hours of service
- Make changes to the Flex Route 2
 - > Eliminating unused stops to accommodate more flexing

2) Find Funding to pay for Outreach and the Expansion of Services

- Niles DART will consider several funding sources that could help with expenses
 - Funding Sources included 5317 New Freedom
 - > 5316 Job Access Reverse Commute (JARC)
 - 5307-Urbanized Area Formula Funding (FTA)
 - CMAQ- Congestion Mitigation and Air Quality Funding Sources
 - > Employers/Chamber of Commerce
 - > SMEGA-Southwest Michigan Economic Growth Alliance
 - Community Block Grant Funding (could potentially be used for public transportation).

3) The need to implement consistent policies for drivers, maintenance workers, and riders

- Niles DART plans to construct a handbook and training for drivers about internal policies and safety requirements
- Niles DART plans to implement a more stringent process for documenting maintenance on buses
- Strengthen current operational policies to create consistent and dependable services for riders
 - In order to change policies, public input is required-Niles will conduct input meetings in the near future

5) Regional Reduced Fare Card Program-Progress Report


The regional reduced fare card program allows seniors 60 years and older and those with disabilities to ride any public transportation system for *half-off* what the regular fares are. The seven transit providers in Berrien, Cass, and Van Buren Counties worked together to produce **one** card that will easily identify those that are eligible for half fares. The Reduced Fare identification cards can be used on any of the systems in this region (and outside the region at the discretion of the transit agency). Applications can be picked up at your nearest transit provider or click **HERE** to print a copy of the application and mail to your nearest transit provider. 6) Consolidation Feasibility Study

On Wednesday, October 26, 2012 Dan Dalton from the KFH Group presented information and facilitated a discussion with transit agencies and stakeholders to ensure that the interpretation of the data and their observations were correct. Since then, Dan Dalton and Bennett Powell from the KFH Group have been analyzing data and information collected during their meetings with key personnel from transit agencies and other stakeholders. All of this information has been compiled into the first technical memorandum which should be available in the upcoming weeks. 7) Pokagon Band Tribal Transit Study

The need for the Pokagon Tribal Transit Study which covers a 10 County service area (4 counties in Michigan and 6 in Indiana) arose out of the Pokagon Band's Long Range Transportation Development Plan. The study will produce a set of recommendations for future tribal transit service. Several transportation options will be investigated such as:

- Entering into a direct service cooperative agreement with an existing public transit service provider
- Investing in new tribe-specific transit service; or
- Continuing with the current level of service provided by existing transit providers.

On Monday, February 13, 2012, the steering committee met and discussed the results of the Pokagon Study's survey as well as provided some recommendations that can be put in place now to assist with the collection of valuable information to be used in determining the best long-term transit options. The Steering Committee is made up of stakeholders from several key Pokagon Band departments such as Pokagon Department of Health, Social Services Department, Education, and the Housing Department.

In moving forward, the next meeting will serve to discuss results discovered from the aggregation of additional data and resources collected.
